Dear Mr. O' Connor:

I have received a copy of your letter to Mr. Don Wilson of 25 Quaker Rd. Princeton Junction, New Jersey, 08550, U.S.A. and found it very interesting. Since your letter indicated that you were interested in what I claimed to have in regards to the mystery on Oak Island I will try to fill you in on a few items. First I would like to know if you are associated with Triton in any way shape or form??? The reason for this question is that if you are you will have access to some of my material that is in the files in Montreal. You will find this material for about August 1970 and it will show the location of the entrance to the money pit and to one other indicated location of treasure or important spot. These locations were never investigated, and up until last July they still hadent been. I visited the island last July and while there I was told that Triton was interested in any thing that would help them to un ravel the mystery. Since there was no work going on at that time on the island, I offered to open up one of the original drains and shut off the water at that point, this was at my own expense and not Tritons, and it would have been in no way in any area that they were interested in. I was told that I didnt know what I was talking about, even without knowing what location I was willing to do it in. I was told that If I was allowed to try, which I was not going to be allowed to do, and was successful in stoping the water, that it still wouldnt prove that I knew what I was talking about. If something is found that has never been known before I would consider that it was new information. If an offer to do something at no cost to them is turned down, I ask you, do they really want to find the treasure or id it realy a con game or tax deduction that they are pulling like somany people have begun to beleave??? In 1970 I had only been working on the codes for a little less then 2 years and had came up with 4 locations. There were 2 locations that I was sure of and 2 that I was gambling on. The 2 that I gambled on I blew and I will admit it. But the other 2 have been verified several ways sinc that time as being correct. I have had articles in the papers and on radio here and in Toronto and from coast to coast in Canada and the U.S. . I have made releases of portions of the maps to some of the publishers that have treasure magazines and which will be released in the future. These releases include the Mar del Map, Capt. Kidd Maps, Entrance Map, Triangle Map, Mystery Stone Map and the numbers 44106818 that Capt. Kidd gave his wife in 1701. I have been able to prove the many lies that have been wound around the mystery of the island and of some people that have made them. I have also put up a \$5,000.00 challenge to Triton on the radio that I am correct and that they have had the location according to the maps for the last 5 years and wouldnt try them. I doubt very seriousley if there is any one in the corporation that is capable of under-

standing them (the break downs for the codes) or wants to. It is not that they are stupid , but it is the simplicity that would baffle them. There are somany people that cant read the numbers 202 back wards and come up with the same answer. They cant understand that a triangle with 3 sides would mean the number 3 , or that a T would stand for 20 which is the 20th letter in the alphabet. If you can read this line backwards and come up with the correct meaning , then you can consider that you are one of the few people that could under stand the codes on the maps. This letter might seem as though I am vety bitter , and I hope that you will over look it , and if you do decide to answer I will give you any answers that you wish to know. That is providing it isnt the complete answer to the island. There really wouldnt be any sence to give you all the answers as there is no one that is actually interested in knowing . All they would say is , GIVE ME A PIECE OF PIE , BUT DONT FILL MY HEAD WITH HOW IT IS MADE , AS I AM NOT INTERESTED.
